AND FOR THE SAID CONSIDERATION:

- a) I confirm that I have reviewed this Release and that I fully understand and accept its contents and the consequences of signing same;
- b) I acknowledge that I have had an adequate opportunity to read and consider this Release and obtain such legal and other advice as I consider advisable, and I have either done so or have consciously decided not to do so;
- c) I acknowledge and agree not to make claim or to commence or take proceedings or continue any proceedings against any other person, firm, partnership, business or corporation who or which might claim contribution from, or be indemnified by, these parties, under the provisions of any statute or otherwise in respect of those matters to which this Release applies.
- d) It is understood and agreed that the payment by the Releasees in relation to the reimbursement is deemed to be no admission whatsoever of liability on the part of the said Releasees;
- e) I represent and warrant that I have not assigned to any person or corporation any of the claims that I release by the paragraph above;
- f) It is understood and agreed that I will not discuss or disclose to anyone the terms of this Release, other than to my legal advisors and such other disclosure as is required by law. I also agree that I will not disparage the Releasees in any communication hereafter, whether orally or in writing; and
- g) I confirm that I have the lawful authority to execute this Release and that I am signing this Release voluntarily, without coercion and without reliance on any representation, express or implied, by the Releasees.
