

I am appreciative but never surprised by the continued resolve and commitment of our Service members

As Chair Drew mentioned, 2021 was another challenging year of navigating the mental, physical and organizational impacts of COVID-19. But despite wave after wave, our members remained focused and committed to their role and duties towards community safety.

I want to acknowledge all of our 1,200 plus members from both the sworn and civilian side that, collectively helped elevate the Service in 2021. Despite the many challenges related to the pandemic, DRPS continued to deliver operationally. DRPS had the third highest weighted clearance rates among our GTA comparators. We know that Durham Region will continue to grow and that the complexity of crime will evolve, but the DRPS will also be progressive in its approach to address areas of concern and community safety.

A Year of Community Engagement

n the early part of 2021, the Board conducted a poll of the community and members on policing issues in Durham Region. The purpose of the poll was to understand perceptions of the DRPS, and following the period of consultation, the Board introduced a draft Action Plan to Enhance Trust and Confidence in Policing, with four key priorities: transparency in decision-making; improving diversity, equity and inclusion practices and procedures; strengthening the response to mental health calls; and supporting the DRPS' four initiatives to address systemic barriers and the Equity and Inclusion Strategic Plan. The Board looks forward to the ongoing implementation of the Plan and to realizing lasting and meaningful change.

Late in the year, the Police Services Board, with the assistance of Environics Research, held public and stakeholder consultations on the qualities and characteristics that should be prioritized in the Board's search for a new Chief of Police. These consultations will serve as the foundation for the Board's leadership recruitment and evaluation of candidates for the Chief of Police position. The Board is grateful for the contributions of all who participated in offering their perspectives to assist the Board in making one of its most important decisions.

The Board bid farewell to Steve deBoer in 2021, following almost three years of service. Mr. deBoer passionately advocated for effective governance practices, and exercised his voice diligently at the Board table, especially on matters that affected the membership and leadership of the DRPS. Diversity Advisory Committee (DAC)

Established to deal with challenges that impact the diverse communities of Durham Region, DAC is made up of appointed citizens who sit as a consultative and advisory body to the Office of the Chief of Police. Enhanced Communication with the Public

In 2021, the Service revamped its approach for reaching the public with timely and relevant information. More than 2,400 public statements were issued, which was a 73% increase from 2020. This increase is partly due to an increase in social media campaigns aimed at crime prevention and public education.

Crime Analysis

The Crime Analysis Unit provides ongoing, crucial analyses that contribute to building a safer community. This is done through mapping and analyzing crime, and identifying and monitoring priority crime patterns and emerging trends. In 2021, the Service increased its focus on identifying and responding to crime in hotspots, assisted with 38 major project investigations and identified 12 significant regional crime trends that were then communicated to members for follow-up.

s we navigated through the first full year of the pandemic, our officers continued to see an increase in dangerous driving behaviours over pre-pandemic numbers. With less travelled roads, officers saw a 23 per cent increase in stunt driving charges to 228 (compared to 185 in 2020). The number of speeding infractions decreased by 14 per cent (7,346) over the previous year (8,415). Overall, dangerous operation violations decreased by seven per cent from 2020, but remained 43 per cent higher than 2019.


Fatal collisions on DRPS-controlled roadways increased in 2021 to 21 (compared to 20 in 2010). There was a slight increase in impaired driving charges — 745 compared to 722 in 2020. An effective R.I.D.E. campaign during the holiday season removed 65 impaired motorists from the roads.

DRPS Traffic Services continues to follow the Durham Vision Zero Strategy, a region-wide road safety strategy led by DRPS and the Regional Municipality of Durham. Part of this strategy focuses on public education – several social media awareness initiatives were executed to raise public awareness about: community safety zones, school bus safety, impaired driving, adjusting driving to weather conditions and speeding.

RPS officers patrol the approximately 2,500 square kilometres that makes up Durham Region, backed up by a team of dedicated civilian members. As the 10th largest municipal police service in Canada, DRPS faces many challenges, but is constantly evolving in order to help prevent and solve issues in the community every day.





Public Complaints

In 2021, the OIPRD received **156 public complaints** with respect to the conduct of either DRPS officers or DRPS services, or policies. This represented a **5.4 percent increase** from the 148 complaints received in 2020. However, it is important to note in 2020, we received 19 public complaints regarding the same matter.

Of the 156 public complaints involving DRPS officers, conduct, services or policies, 81 were addressed by the OIPRD as follows

- 75 were screened out by the OIPRD and closed based on the criteria outlined in the Oversight Appendix.
- One was withdrawn before screening
- Five were assigned to third-party police services for investigations and, at
 the time of writing, one was resolved by Informal Resolution, three were
 unsubstantiated and one is still under investigation.

Special Investigations Unit

he Special Investigations Unit (SIU) is the civilian oversight agency responsible for investigating circumstances involving police that have resulted in a death, serious injury, or allegations of sexual assault of a civilian in Ontario, Canada. In 2021, the SIU invoked their mandate 15 times in Durham, compared to 10 times in 2020. One of those cases are pending, criminal charges were laid in one of the cases, nine were closed with no further action, and four were terminated and had no report filed with the Attorney General.

The **remaining 75 public complaints** were assigned to DRPS PSU for investigation. This is a **33.9 percent increase** from the 56 that were assigned to PSU in 2020.

60 of those public complaints have been resolved as follows:

- Five were resolved by way of Early Resolution,
- 19 were closed by way of Informal Resolution Agreement (after mediation with PSU investigators).
- One was terminated by OIPRD,
- One was terminated by PSU (unable to investigate),
- 11 were deemed unsubstantiated, and
- 23 were withdrawn by the complainants (after mediation with PSU investigators).

The remaining 15 public complaints are still under investigation.

Street Checks

A regulation in the Police Services Act, known as the Collection of Identifying Information in Certain Circumstances — also known as street checks — defines a police interaction and regulates how identifying information may be collected. In 2021, no street checks were conducted by DRPS officers. Therefore, there were no public complaints, general information requests or personal record information requests made under the Municipal Freedom of Information and Privacy Act relating to information collected pursuant to the Regulation. There were no instances in which a police officer did not carry out their duty to inform the individual for the reasons outlined in Section 6 of the Regulation or where an individual was not given a receipt document because the individual did not indicate that they wanted it. As there were no attempted collections, there were no instances where an officer did not provide a receipt for any of the reasons prescribed in the Regulation. The restricted database was not accessed for any purpose in 2021.

Joint Force Operations

Every year, a number of DRPS investigations involve working with police services across Ontario, Canada and sometimes globally. Our members are embedded in a number of Joint Forces Operations to share information with other police services, and federal and provincial authorities. These include the Provincial Asset Forfeiture Unit; the Provincial Biker Enforcement Unit; the Provincial Weapons Enforcement Unit; the Criminal Intelligence Service of Ontario; the Provincial Anti-Terrorism Section; the Integrated National Security Enforcement Team; the Combined Forces Special Enforcement Unit and the Repeat Offender Parole Enforcement squad.

Project Kakia is an amazing example of a successful JFO partnership from 2021. This was a six-month multi-jurisdictional investigation led by the DRPS Gun and Gang Enforcement Unit in partnership with the Royal Canadian Mounted Police Transnational Serious and Organized Crime Unit. Further support and funding was provided by the Ontario Government, Criminal Intelligence Service Ontario.

Use of Force

As of Jan. 1, 2020, the Ontario government implemented a standardized system of "use of force" reporting by all police services. In 2021, 243 out of 113,352 police calls received by DRPS met the threshold for mandatory reporting. This amounts to approximately 0.2 per cent of all calls (not including traffic stops and other undispatched-officer contact with the public). This reflects the professional, strategic and purposeful manner in which our officers engage the members of our community on a daily basis, as well as their commitment to making the Region of Durham a safe community in which to live, work and play. It is also a testament to our rigorous officer training to use force as a last resort.
